STUDENT ADVISORY

In continuation of the advisory received from the Office of the Proctor, University of Delhi, and in light of the message issued by the Hon'ble Vice Chancellor, Delhi University, all students of Bhaskaracharya College of Applied Sciences are hereby informed of the following:

- i) Public meetings, rallies, processions, demonstrations, protests, dharnas, agitations of any kind are strictly prohibited within the College campus till further notice as and when notified by the competent authority.
- ii) Activities such as slogan shouting, public speeches, or any action that may disturb academic functioning or social environment, public tranquillity, obstruct traffic, or affect law and order are prohibited. Carrying of items like hazardous materials, beacons, torches, or similar items, showing of black flags is also strictly prohibited and may lead to strict disciplinary action as per University rules.
- iii) **Students are also advised not to post, share, or circulate any controversial, sensitive, or provocative content on social media platforms or WhatsApp groups that may disturb harmony, create discord, or affect the peaceful environment of the college.** Responsible and respectful online conduct expected from all stake holders.

All students are requested to cooperate with the administration and uphold the dignity and reputation of Bhaskaracharya College and the University of Delhi. The Hon'ble Vice Chancellor has also urged all members of the University community to maintain harmony, avoid discord, and respect institutional processes while awaiting decisions on relevant regulatory matters.

This advisory is issued in the interest of maintaining safety, discipline, and academic normalcy in the college campus.

ORDER

The undersigned hereby informs all students, faculty members, and staff of the University of Delhi that public meetings, processions, demonstrations, and protests of any kind are strictly prohibited within the University Campus for a period of one month.

This order is issued in view of information received indicating that unrestricted public gatherings, processions, or demonstrations on campus may lead to obstruction of traffic, threats to human life, and disturbance of public peace. In the past, organizers have often failed to control such protests, which have escalated and spread widely, resulting in deterioration of law and order within the University campuses.

In this context, it is further informed that the Assistant Commissioner of Police, Sub-Division Civil Lines, has also issued an order vide Order No. 18441-18550/R/ACP/Civil Lines, Delhi dated 26.12.2025, read with Notification No. U-11036/3/1978(i)-UTL dated 01.07.1978 of the Ministry of Home Affairs, Government of India, New Delhi, and Notification No. F.No. 110036(i)UTL dated 09.09.2010 of the Ministry of Home Affairs, Government of India, New Delhi, wherein the following activities have been prohibited:

- i) Holding of any public meeting, rally, dharna, protest, or agitation.
- ii) Assembly of five or more persons.
- iii) Carrying of any hazardous materials, including Mashals/Beacons/Torches, etc.
- iv) Engaging in any activity that may affect the general tranquillity of the public or the smooth flow of traffic.
- v) Shouting of slogans and making speeches.

This order shall come into force with effect from **17th February 2026** and shall remain in force for a period of one month, unless withdrawn earlier.

This order is issued with the approval of the Competent Authority.
